7. Applicant, for itself and its parent company, understands and agrees that if the Permit is granted it shall also be subject to the following special limitations, which are hereby incorporated into the Permit by this reference:

A. Boring and Depth:

There will be no boring allowed in right of ways at road crossings or driveways for temporary steel and aluminum lines.

B. Relocation:

Applicant, upon 30 days written notice, agrees to relocate utilities should it interfere with County construction or maintenance.

C. Notice to Commissioners:

Applicant shall provide 5 days notice to Commissioners of the move-in date for construction or maintenance of utilities. Such notice shall be given by written letter addressed as follows:

D. Entrance Construction Notice to Commissioners:

Adequate and safe entrance on county road shall be at the discretion of the County Commissioner of that district and Commissioner shall be contacted no less than 5 days prior to start date of construction project. Notification by phone shall be given to the following Commissioners:

E. Notices to Applicant:

Any and all notices required to be sent hereunder to Applicant may be sent to the address as set forth in # 1 above.

F. Compliance with State and Federal Law:

Applicant warrants that it is, and at all times during the pendency of the permit shall be in full compliance with all state and federal laws governing Applicant's utility work.

G. Change in Ownership

Applicant and its successors and assigns shall furnish notice to Commissioners of any change in ownership of its utility system, or any part thereof, or of any change in the controlling ownership of the capital stock or other such ownership interest relating to the utility system located in the County, and shall within 30 days of such change, provide Commissioners with the name of such new owner, its address, telephone number, contact person, and the effective date of such change of ownership.

H. Other Requirements:

The granting of the permit may be subject to additional requirements as set forth in the permit itself. Failure to abide to rules of condition of Beckham County Right of Way permit will be considered a breach of contract, resulting in ceasing of work. The previous approved permit will be declared null and void. A new permit will need to be submitted for approval or denial by the Beckham County Commissioners before work can resume or continue.

I. Damages and Indemnification:

Applicant shall pay, defend, hold harmless, and indemnify the County Commissioners and the County they represent for and/or from any loss, expense, cost, charge, damage, claim or attorney fees resulting from the construction, operation, and maintenance, or lack thereof, of utilities contemplated hereby or resulting from any breach of the conditions, warranties, and special limitations of the applicant and the permit.

J. Fees:

This Application must be submitted to the County Commissioners for approval by the Board of County Commissioners along with a fee of **\$500.00 per entrance** made payable to the County Treasurer of Beckham County.

K. Incorporation of Terms and Conditions:

Upon the approval of the Application by the County Commissioners, the Permit set out herein shall be granted, subject to the full compliance with the terms and conditions of the Application and any special requests set forth in the Permit.

L. Successors and Assigns:

The terms and conditions hereof shall be binding upon the successors and assigns of the Applicant.
