## REGULAR COMMISSIONER'S MEETING NOVEMBER 24, 2008

The Beckham County Board of Commissioner's met Monday, November 24, 2008 at 9:00 A.M. in their office at the Courthouse for which the time, place and agenda had been posted. The meeting was called to order by Carl Don Campbell. Present were Carl Don Campbell, Chairman, Carl Simon and Johnny Davis, members. Also present were Ginger Pope, County Clerk, Cindy Marshall, First Deputy County Clerk and Lonnie Risenhoover, Emergency Management and Safety Director.

A motion of Mr. Simon second of Mr. Davis to approve the minutes of the regular meeting of November 17, 2008. AYE: Campbell-Simon-Davis.

A motion of Mr. Davis second of Mr. Simon to approve the 2 road crossing permits for Bearcat Land, Inc. 1. Between NE/4 of Sec. 34-10N-23W & NW/4 of Sec.35-10N-23W and 2. Between SW/4 of Sec. 26-10N-23W and NW/4 of Sec. 35-10N-23W. AYE: Campbell-Simon-Davis

A motion of Mr. Simon second of Mr. Davis to approve commissioners sale of property described as Lot 7, Block 9, Vaugh Addition, Erick, Oklahoma. AYE: Campbell-Simon-Davis

Tom Carpenter and Trisha Parker, Representatives with HealthChoice were present to review all of the benefits that HealthChoice had and still has to offer Beckham County Employees. After their presentation Mr. Carpenter & Ms. Parker open up the floor for questions about HealthChoice and asked why Beckham County may want to change to another Health Insurance Plan or Company. (HealthChoice is currently the health insurance for Beckham County) The Board of County Commissioners agreed that HealthChoice has good benefits & health coverage but that the Premiums of HealthChoice was becoming too high for most employees to cover their families. The Board of County Commissioners felt that in the best interest of Beckham County Employees and for the employees to have the opportunity to provide insurance coverage for their families, the Board wanted to check out other health insurance companies with lower premiums but also have good benefits or health coverage. Mr. Carpenter and Ms. Parker stated that if Beckham County no longer chose to be with HealthChoice then HealthChoice would need 30 days notice that they no longer will be with Beckham County. The Board of Commissioners stated that they will discuss this further and notified HealthChoice of their decision.

A motion of Mr. Davis second of Mr. Simon to approve Resolution #08-70 concerning bridge inspection responsibility by local government for compliance with national bridge inspection standards. AYE: Campbell-Simon-Davis

Bid opening for Asbestos Abatement for the old county jail building. Two bids were received at the time of bid opening. Environmental Action, Inc. bid in the amount of \$21,850.00 and MidSouth Abatement Co., Inc. bid in the amount of \$17,500.00. A motion of Mr. Simon second of Mr. Campbell to approve Resolution #08-69 for appointment of Johnny Davis as Representative to the Board of the Oklahoma Public Employees Health & Welfare Plan. AYE: Campbell-Simon-Davis.

A motion of Mr. Simon second of Mr. Davis to approve Resolution #08-68 to change Speed Limit to 35 MPH on County Road 1720 on North side of Sweetwater School (Intersection 1720 & 1110 going west for ½ mile . AYE: Campbell-Simon-Davis.
