Beckham County Sheriff Scott Jay as present to discuss Jail operations. Sheriff department is looking at various Food Services to contract with them to feed inmates, instead of buying food directly and preparing the meals. Sheriff Jay thought that this may save on their current food bill. Also Sheriff Jay expresses his concerns with losing revenue from housing DOC inmates. State has been picking up their DOC inmates as soon as possible; therefore Sheriff Department is not receiving as much revenue to house the inmates for DOC department.

Discussion of Medical Bill of Mathew Dixon, inmate of the Beckham County Sheriff Department. Mr. Dixon was attacked while serving time in the Beckham County Jail which resulted in Mr. Dixon receiving medical care. Current medical bill to date is \$3,406.94 in which Sheriff Jay express is concern to have the Beckham County Jail Facilities help pay this expense. Mr. Sprowls stated that the Beckham County Facilities Authority was not set up to pay medical bills of inmates and that Sheriff Jay should take this matter up with the Beckham County Commissioners Board. Sheriff Jay stated that he would present this to the Board of County Commissioners.

Beckham County Treasurer, Janette Cornelius was present to discuss a CD that will mature on March 5, 2011. Next regular schedule meeting date would not be until March 15, 2011 therefore, Ms. Cornelius was wondering what the Beckham County Facilities Board wanted her to do. Mr. Sprowls stated that Ms. Cornelius has the authority to reinvest the CD into whichever Bank or Facility in which would give the best interest rate.
