Nathan D. Ellis, Attorney with The Public Finance Law Group addressed the Board of County Commissioners regarding Elk City Economic Development Project. The purpose of the Increment District is to encourage economic development in the City by facilitating the creation of significant additional commercial and industrial development along the Interstate 40 corridor within the City that

encourages commerce, increases retail opportunities, and generates a corresponding growth in the local tax base. The expectation is to complete a majority of the infrastructure improvements as soon as possible; however, certain sufficient Tax Increment Finance Revenues are generated by the Increment District. As part of this process, Elk City proposes to make available approximately \$3.0 million in economic incentives to entice the location of commercial big box retailer with Elk City that would not otherwise occur but for this Project, in an attempt to realize a critical mass of development that will benefit the long term tax base. He discussed the impact of Sales Tax and Ad Valorem collections to the county. Assessor, Gayla Gillie and Health Department Administrative Director, Karen Weaver represent the County on the T.I.F. Review Board.

Carl Simon had to leave the meeting.
