The permit amendment is to construct a 5.2 mile overhead transmission line in Beckham County that would include four County Road crossings. The two additional road crossings would span N1730 and N1740 roads. The utility crossing permit fee of \$1,000.00 will be paid to Beckham County. Motion made by Carl Simon to approve the utility crossing permit amendment. Johnny Davis seconded the motion with Simon and Davis voting aye.

Motion made by Johnny Davis to approve 2011/2012 contract with ROCMND Area Youth Services operating the Craig Country Juvenile Detention Center. Carl Simon seconded the motion with Simon and Davis voting aye.

Johnny Davis made the motion to approve 2011/2012 Public works project contract with Oklahoma Department of Corrections. Carl Simon seconded the motion with Simon and Davis voting aye.

Carl Simon made the motion to accept bid from Land Services for oil & gas lease covering Block H of the Maywood Addition to the City of Elk City. Net mineral acres, 0.5177, term 3 years, royalty 3/16 lease bonus \$1750 per net mineral acre. Johnny Davis seconded the motion with Simon and Davis voting aye.
