Under sheriff Mike Bagzis presented a lease-purchase agreement from Ford Credit to be approved. The Sheriff office would like to lease (2) 2011 Dodge Charger Police Cars. The cost will be paid from the Sheriff Commissary account. Johnny Davis made a motion to approve the lease purchase agreement. The Commissioners discussed Emergency Management and Commissioners Executive Assistant salaries to come from General account 20-10 for fiscal year 2011-2012. Janette Cornelius discussed with the Commissioners the four investments of T-Hwy monies. The interest at this time is less than 1%; one CD is up for renewal today. The CD amount is \$155,000.00, Carl Simon made a motion to draw down the CD and deposit to T-Hwy account. Johnny Davis seconded the motion with Campbell, Simon and Davis voting aye.

Carl Simon made a motion to adopt the Commissioners District lines as prepared by SWODA. Johnny Davis seconded the motion with Campbell, Simon and Davis voting aye.
