They would like SWODA to participate in Planning & Zoning Board meetings, update policy book. Motion made by Johnny Davis to approve contract for fiscal year 2011 -2012. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

Motion made by Johnny Davis to approve contract between Beckham County Health Department and Kristina McWhorter for Directly Observed Therapy. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

Motion made by Carl Simon to approve contract between Beckham County Health Department and Community Action Development Corporation Head Start Program. Sites included are Erick, Hammon and Sayre. Johnny Davis seconded the motion with Campbell, Simon and Davis voting aye. Chris Belford, Warren Cat Governmental Sales Rep., presented a lease purchase agreement for Cat Model D6TXL Track Tractor, s/n LAY00893. Motion made by Carl Simon to approve this agreement with Empire Financial Service of Tulsa. Johnny Davis seconded the motion with Campbell, Simon and Davis voting aye.

**Resolution #11-41** Title 19 section 321 requires a county to be divided into three districts by the Board of County Commissioners as equal in population as practical. Population is as follows; District #1, 7393; District #2, 7395; District #3, 7331. Motion made by Johnny Davis to approve district boundaries. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye. **Resolution #11-42** The Board of County Commissioners of Beckham County, joins with other counties in creating the ACCO Self-Insurance Group. Motion made by Johnny Davis to approve resolution #11-42. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

Motion made by Carl Simon to approve property & liability insurance offered through ACCO. Policy term is July 1, 2011 through June 30, 2012 at a cost of \$141,590.00 and will be paid in two payments. Johnny Davis seconded the motion with Campbell, Simon and Davis voting aye.

The Commissioners discussed Senate Bill 1910. New language added to Title 26, section 2-118 permits but does not require counties to provide an amount of additional compensation to the County Election Board Secretary. Motion made by Johnny Davis to provide a monthly longevity pay to the Election Board Secretary. With the addition of longevity pay the salary of Election Board Secretary will be equal to First Deputy salary. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

The Commissioners discussed the salary of Election Board Clerk. Motion made by Johnny Davis to increase Election Board Clerk to same hourly wage as Second Deputy salary. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

No unfinished business to be discussed.

Lonnie Risenhoover updated the Commissioners on 911 system.
