The Board discussed the County Budget for FY 2011-2012. The General Fund estimate of needs is \$7,818.933.39. The board will present budget to Excise Board Sept. 7th for approval.

Resolution #11-48 The Beckham County board of Commissioners shall transfer funds from General Fund Acct. #253-20 Emergency Mgmt5. S.L.A. to Emergency Mgmt Cash Acct. #112-20 for the purpose of closing out the Emergency Mgmt funds within the General Fund in the amount of \$489.50. ONEOK NGL PIPELINE presented an application for (14) Gas Carrying Underground Pipeline Crossing Facilities. The proposed crossing will be located on the following county roads; N1670, N1680, N1690, N1710, E1140 (3), N1720, N1730, N1740, N1750, N1760, N1770, N1780. The permit fee of \$1,400.00 was paid. Lonnie Risenhoover presented the Board with the Emergency Operations Plan for Beckham County and the cities/towns therein. This plan supersedes and pervious emergency management/civil defense plans made by the County. Carl Simon made a motion to approve the plan.
