

Minutes of the Beckham County Election Board regular meeting held Friday, March 9, 2012 4:00 p.m. at the County Election Board Office, 306 E Main Street, Sayre, OK. Advanced public notice was performed by filing a written notice with the County Clerk on December 7, 2011. The agenda was posted on March 7, 2012 at 12:30 pm. Copies of the notice and agenda are attached.

The following members were present: Shirley Waters, Vice Chairman and Deidre O'Briant, Secretary. Virginia Strong, Beckham County Election Board Chief Clerk and Jan Helling, representative of the Beckham County Sheriff's office were also present. In the absence of Chairman Jay Kirby, Mrs. Waters called the meeting to order at 4:10 pm.

BUSINESS CONDUCTED

1. Discuss and approve the minutes of the meeting held March 6, 2012. Action taken: Mrs. Waters moved to approve the minutes. Mrs. O'Briant seconded the motion. Roll Call Vote: Waters aye, O'Briant aye. Motion passed 2-0.

Mr. Kirby arrived at 4:15 and Mrs. Waters turned the meeting over to him.

2. Canvass and count verified provisional ballots for the March 6, 2012 Presidential Preferential Primary and Elk City Special Municipal Election. The Board canvassed a total of two provisional ballots that were cast and verified as eligible to be counted. The Board observed the counting of the provisional ballots. Action taken: None. Board action is not required. The counted ballots were placed into the custody of Mrs. Helling of the Sheriff's office for security until the end of the contest period at 5pm.
3. Recess, if necessary, and reconvene at 5pm in the same location. Mr. Kirby moved to recess until 5pm. Mrs. Waters seconded the motion. Roll call vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 2-0. At 5pm, Mr. Kirby called the meeting back to order.
4. Certify the results for the March 6, 2012 Presidential Preferential Primary. Action taken: Mrs. O'Briant moved to certify the results. Mr. Kirby seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0. A copy of the Official Certification is attached to the minutes.
5. Certify the results for the March 6, 2012 Elk City Special Municipal Election. Action taken: Mrs. O'Briant moved to certify the results. Mr. Kirby seconded the motion. 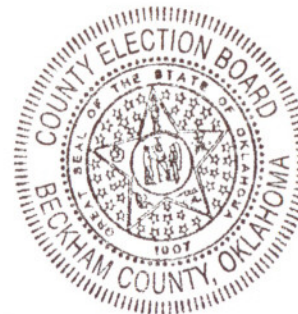

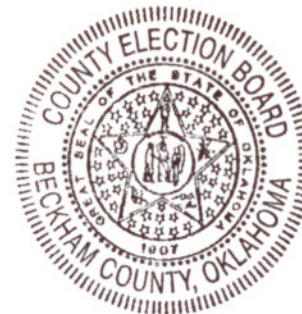

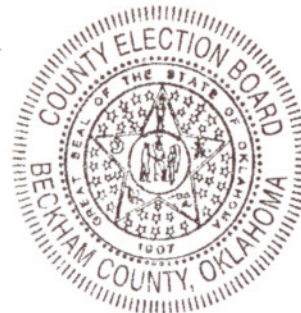
