Motion made by Johnny Davis to approve agreement with Eastern Oklahoma Youth Services for juvenile detention. Term of the agreement is July 1, 2011 through June 30, 2012. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye.

The Board received notice of intent to place a manufactured home at 702 N. 5th Sayre, which the County owns property within a radius of three hundred feet from the outside perimeter of the property line of the proposed location. The Board saw no reason to protest this placement.

SWODA informed the Board that the Beckham County Rural Water District #1 was approved for funding in the amount of \$100,000.00 from Rural Economic Action Plan. Johnny Davis made a motion to accept the grant. Carl Simon seconded the motion with Campbell, Simon and Davis voting aye. No unfinished business to be discussed.
