Greg Hartman, County Extension Director discussed with the Board the financial situation the Oklahoma Cooperative Extension Services is facing. Over the past three years OCES has had its federal and state funding cut. OCES has implemented a new salary sharing program starting with FY13. The County will be asked to pay 1% of salary for the base staff for FY 13; 2% in FY14; and 3% in FY 15 and beyond. Greg said the office County budget will be able to pay for FY13, but he just wanted the Commissioners to realize what the Extension office faces in the future.

Motion made by Carl Don Campbell to approve Public Works Project Contract with Oklahoma Department of Corrections July 1, 2012 through June 30, 2013. Johnny Davis seconded the motion with Simon, Davis and Campbell voting aye.

Motion made by Carl Don Campbell to approve the one and five year road & bridge plans for all three highway districts. Johnny Davis seconded the motion with Simon, Davis and Campbell voting aye. Sheriff Scott Jay presented a Ford Motor Credit application for the purchase of a new four-wheel drive Tahoe for his department. The purchase will be made from the sheriff fee capital outlay account. Carl Don Campbell made a motion to approve the purchase. Johnny Davis seconded the motion with Simon, Davis and Campbell voting aye.

Sheriff Scott Jay told the Board the walk-in freezer was complete. He presented a contract from US Foods Essensa, which would allow the Sheriff's office to buy food in bulk at a savings to the County.
