Atlas Resin Proppants, LLC will be transporting resin coated sand products from rail to trucks. Several Erick residents were present to voice concerns. Gayla Dunlap gave the Board copies of safety data from the Atlas Resin Proppants website regarding the health hazard of the sand. Linda Dyles said she was very concerned for her and the neighbor's health, the traffic in the area, the view from her property and value of surrounding property. Donita Hawkins was concerned about how the facility would be set up and operated. Debra Glascow, SWODA Representative, said there would be several environmental agencies that would be contacted for approval and studies of the future project. Motion made by Carl Don Campbell to approve the zoning change as recommended by the Planning and Zoning Board from Agriculture to Commercial. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

The Board reviewed the Justice Assistance Grant application for the Sheriff Office. The grant will be for three mobile data terminals (tablets), mounts, and software \$9,765.00.
