Resolution #13-6 Oklahoma State Election Board has allotted special federal funds to assist County Election Boards in complying with the Help America Vote Act. Reimbursement will be to purchase computers, printers, and installation of said equipment. Upon reimbursement, the County Election Board will make a deposit to the County General Fund. Motion made by Carl Don Campbell to adopt resolution #13-6 effective Jan. 7th, 2013. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

Resolution #13-7 The County Commissioners Board authorizes and directs the County Treasurer to reimburse the County Election Board General Fund the amount remaining in Special Depository Account after the general election expenses. Carl Don Campbell made a motion to adopt resolution #13-7 effective Jan. 7th, 2013. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

Resolution #13-8 The County Commissioners Board appoints Shannon Sawyer, Human Resources Clerk, to represent Beckham County on the OPEH&W Health Plan Board in place of Johnny Davis. Carl Don Campbell made a motion to adopt resolution #13-8 effective Jan. 7th, 2013. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

District #2 has two open positions on the County Fair Board. Buddy Carnes recommended Dillon Partain and Gary Thetford. They are both willing to serve. The election laws for this Board have changed effective Jan. 1, 2013 current members are retained for an additional two years then an election will be conducted by the County Election Board. Buddy Carnes made a motion to appoint Dillon Partain & Gary Thetford to County Fair Board effective Jan. 7th, 2013. Carl Don Campbell seconded the motion with Davis, Campbell and Carnes voting aye.

The Board discussed a new vehicle for the Emergency Management Director. The pickup he is now driving will be transferred to District #3. Carl Don Campbell made a motion to get a 2013 Ford Expedition XL 4X4 from the State Bid list or local vendor if cheaper than State Bid. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.
