Mart Tisdal & Luke Adams with Tisdal & O'Hara Law Firm discussed with the Board the delinquent personal property tax case of Masefield Natural Gas, Inc. Mart told the Board at this point he didn't foresee Masefield paying the past due taxes without taking court action to sue the company. The amount past due is \$137,284.79 for tax year 2009 & 2010. A tax lien will be filed and a judgment rendered that would attach to the company's assets in Texas where they are now doing business. Motion made by Carl Don Campbell to hire Tisdal & O'Hara Firm to represent the County and file suit against Masefield Natural Gas, Inc. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

The Beckham County Planning & Zoning Board recommends changing the zoning status from agriculture to industrial uses permitted on review for National Oilwell Varco, 11566 Highway 6 Elk City, OK. Motion made by Carl Don Campbell to change zoning status as recommended. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

Chesapeake Energy presents application to work within Beckham County Highway System, right of way (entrance). The proposed work will be located NE/4 S35T11NR26W. The permit fee of \$500.00 is included. Motion made by Carl Don Campbell to approve permit application. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

Motion made by Carl Don Campbell to update lease agreement for property at 111 W. Main Sayre. Previous owner was Marie Allison, now her daughter Kathy Sawyer. Buddy Carnes seconded the motion with Davis, Campbell and Carnes voting aye.

Treasurer, Janette Cornelius presented State Auditor cash flow audit report. Audit was preformed Jan. 11th, 2013. The audit process checks bank reconciliations, confirm the investments, reconciliation of general ledger, verify deposits and invested funds are secured by pledged collateral. According to Gary Jones, State Auditor & Inspector no exceptions were noted.
