Motion made by Buddy Carnes to approve Transfer of Appropriations. Johnny Davis seconded the motion with Campbell, Carnes and Davis voting aye.

Motion made by Buddy Carnes to approve County Officers Monthly Reports. Johnny Davis seconded the motion with Campbell, Carnes and Davis voting aye.

Motion made by Buddy Carnes to solicit unleaded & diesel fuel bids for District #2 & #3 by phone. Johnny Davis seconded the motion with Campbell, Carnes and Davis voting aye.

Motion made by Johnny Davis to approve September Longevity pay. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Cheryl St. Clair, National Center for Rural Health Works from Oklahoma State University addressed the Board regarding State Question 522 that was passed by the Oklahoma voters. This allows a district to be formed to fund Emergency Medical Services. An annual recurring ad valorem tax levy of not more than three mills per dollar of assessed valuation of all taxable property in the district for EMS operations. The Board of County Commissioners would call for a vote of the people whether to form the district and authorize a tax levy not to exceed three mills. Motion made by Johnny Davis to call for an election of the Beckham County voters, to form

522 District and fund with 3 mills tax levy. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Motion made by Johnny Davis to add signage criteria to the Beckham County Utility Crossing Application. The sign will have company name and telephone number and posted at all crossings and all driveway entrances. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Linn Operating, Inc. presents Application for Gas Carrying Underground Pipeline Crossing Facility. The proposed work will be located NW/C of NW/4 S29T11NR25W and cross under CR E1110 into SW/4 S20T11NR25W. The permit fee of \$1,000.00 is included. Motion made by Johnny Davis to approve application. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Resolution #2014-50 The Board of Beckham County Commissioners need to temporarily change the speed limit from 55 mph to 35 mph from Hwy 30 & CR1190 thence 1 mile east and from CR1750 to CR1190 thence 1 mile south. This change will be in effect until ODOT finishes bridge repairs. Motion made by Buddy Carnes to adopt resolution #2014-50 effective Oct. 6th, 2014. Johnny Davis seconded the motion with Campbell, Carnes and Davis voting aye.

Resolution #2014-49 The Board of Beckham County Commissioners need to place a stop sign at CR1190 & CR1750 going north. Motion made by Buddy Carnes to adopt resolution #2014-49 effective Oct. 6th, 2014. Johnny Davis seconded the motion with Campbell, Carnes and Davis voting aye.

Motion made by Johnny Davis to table vote on CTC Janitorial uniform service. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Undersheriff Jeff Bilbo is asking the Commissioners to pay for a new computer server at an estimated cost of \$8,700.00. Carl Don Campbell said he had looked at the Sheriff's account balances and concluded that the Sheriff had more than enough to make this purchase. Motion made by Buddy Carnes to disapprove payment from the General Fund for this purchase. Johnny Davis seconded this motion with Campbell, Carnes and Davis voting aye.

Jason's Ditching Service presents Application for Permit Utility/Service Crossing. The proposed work will be a total of six crossings, Hwy 152 & CR1750, CRN1860 & CRE1130, and CRN1890 & CRE1170. The permit fee of \$6,000.00 is included. Motion made by Johnny Davis to approve application. Buddy Carnes seconded the motion with Campbell, Carnes and Davis voting aye.

Oneflow Energy Services presents Application for Permit Utility/Service Crossing. The proposed work will be a total of five crossings located in S34T11NR26W and ending in S2T11NR26W.
