


Minutes of the Beckham County Election Board regular meeting held April 10, 2015 at 4:00 p.m. at the County Election Board Office, 306 E Main Street, Sayre, OK. Advanced public notice was performed by filing a written notice with the County Clerk on December 1, 2014. The agenda was posted Thursday, April 9, 2015 at 8:00 a.m. Copies of the notice and agenda are attached to the minutes in the permanent file.

A quorum was not present until 4:30 pm. At that time, Jay Kirby, Chairman, called the meeting to order. Other members present were Shirley Waters, Vice Chairman and Deidre O'Briant, Secretary.

BUSINESS CONDUCTED

1. Discuss and approve the minutes of the meeting held April 7, 2015. Action taken: Mrs. Waters moved to approve the minutes. Mr. Kirby seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0.

3. Canvass and county verified provisional ballots for the April 7, 2015 Municipal General and Special County Elections. The Board opened the verified provisional ballots and observed the counting of said ballots by the Chief Clerk using a voting device designated for this purpose. Action taken: None. Board action isn't required.
4. Recess, if necessary, and reconvene at 5pm in the same location. Mrs. O'Briant moved to recess. Mrs. Waters seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0.
