Motion made by Carl Don Campbell to approve Cash Fund Estimate of Needs and Request for Appropriation. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

Motion made by Carl Don Campbell to approve Transfer of Appropriations. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

Motion made by Carl Don Campbell to approve Officers Monthly Reports. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

Motion made by Johnny Davis to solicit diesel & unleaded fuel bids for District #2. Carl Don Campbell seconded the motion with Carnes, Davis and Campbell voting aye.

Motion made by Carl Don Campbell to approve longevity pay for June. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

The Board reviewed agreement between Board of County Commissioners and Oklahoma Department of Human Services. OKDHS will reimburse the County \$14,314.32 per FY 15/16 for office space located at 102 S. 3<sup>rd</sup>, Sayre. Motion made by Carl Don Campbell to approve agreement. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

The Board reviewed memorandum of understanding between North Fork Correctional Facility and Beckham County Commissioners for FY 15/16. Commissioners agree NFCF can temporarily house the NFCF inmate population at the Beckham County Activity Barn in the event of a natural disaster at NFCF. Motion made by Carl Don Campbell to approve this agreement. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

The Board reviewed two quotes for Courthouse roof repairs. Motion made by Johnny Davis to award the work to Nurnberg Roofing, LLC at a cost not to exceed \$13,000.00. Carl Don Campbell seconded the motion with Carnes, Davis and Campbell voting aye.

David Floyd and Ryan McDonald explained the new bond for Merritt School District, which the tax payers did pass last fall. The Beckham County Educational Facilities Authority share no liability for debt or construction. This Board is the means by which Merritt School can borrow the money needed for construction. Motion made by Carl Don Campbell to authorize the Educational Facilities Authority to enter into agreement with Merritt School to secure bonds not to exceed \$9,000,000.00. Johnny Davis seconded the motion with Carnes, Davis and Campbell voting aye.

The Board reviewed the contract between Board of County Commissioners and Turn Key Health Clinics for onsite inmate medical services. Jan Helling said the contract had been approved by Gina Webb, Assistant DA. Motion made by Johnny Davis to approve medical contract for FY 15/16. Carl Don Campbell seconded the motion with Carnes, Davis and Campbell voting aye.

No unfinished business.

Jan Helling said the 1982 pickup that belongs to Sheriff Department is in need of repairs.
