



Minutes of the Beckham County Election Board regular meeting held June 30, 2015 at 1:30 p.m. at the County Election Board Office, 306 E Main Street, Sayre, OK. Advanced public notice was performed by filing a written notice with the County Clerk on December 1, 2014. 
The following members were present: Jay Kirby, Chairman; Shirley Waters, Vice Chairman and Deidre O'Briant, Secretary. Mr. Kirby called the meeting to order.

BUSINESS CONDUCTED

1. Discuss and approve the minutes of the meeting held June 1, 2015. Mr. Kirby moved to approve the minutes. Mrs. Waters seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0.
2. Appoint Precinct Inspectors as necessary. Mrs. O'Briant reminded the Board that Inspectors do not serve a designated term as Judges and Clerks do and there is only one vacancy at this time. She moved to appoint Peggy Patten to the position of Inspector in Precinct 320 and to acknowledge all Precinct Inspectors with a letter of appreciation. Mrs. Waters seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0.
3. Appoint Precinct Judges for the period of July 1, 2015 to June 30, 2019. Mrs. O'Briant stated that the list of Democrat Judges has been approved by the Democrat Party. At this time the Republican Party has no Central Committee and the deadline for their approval has expired. It was noted that a vacancy needed to be filled in Precincts 115, 141 and 330 but only one person has been recruited at this time. She moved to appoint the list of Judges as presented to the Board. Mrs. Waters seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0. (a list of those appointed is attached)
4. Appoint Precinct Clerks for the period of July 1, 2015 to June 30, 2019. Mrs. O'Briant stated that the list of Democrat Clerks has been approved by the Democrat Party. At this time, the Republican Party has no Central Committee and the deadline for their approval has expired. It was noted there are no current vacancies to fill. She moved to appoint the list of Clerks as presented to the Board. Mr. Kirby seconded the motion. Roll Call Vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0. (a list of those appointed is attached)
5. Adjourn. Mrs. O'Briant stated that Alternate Precinct Officials are not appointed. As business was concluded, she moved to adjourn. Mr. Kirby seconded the motion. Roll call vote: Kirby aye, Waters aye, O'Briant aye. Motion passed 3-0.
