

Minutes of the Beckham County Election Board special meeting held September 11, 2015 at 4:00 p.m. at the County Election Board Office, 306 E Main Street, Sayre, OK. Advanced public notice was performed by filing a written notice with the County Clerk on August 26, 2015. The agenda was posted Wednesday, September 9, 2015 at 11:45 AM. Copies of the notice and agenda are attached to the minutes in the permanent file.

A quorum was not present until 4:30 pm. At that time, Jay Kirby, Chairman and Deidre O'Briant Secretary were in attendance. Shirley Waters, Vice Chairman, was absent. Also present were Virginia Strong, Chief Clerk and Jan Heling, representative of the Sheriff's office.

#### BUSINESS CONDUCTED

1. Discuss and approve the minutes of the meeting held September 8, 2015. Mr. Kirby moved to approve the minutes. Mrs. O'Briant seconded the motion. Roll Call Vote: Kirby aye, O'Briant aye. Motion passed 2-0.
2. Count verified provisional ballots for the September 8, 2015 Special Election for Sayre School District I-31. The Board opened the 3 verified provisional ballots and observed the counting of said ballots by the Chief Clerk using a voting device designated for this purpose. Action taken: none. Board action is not required.
3. Recess, if necessary, and reconvene at 5pm in the same location. Mr. Kirby moved to recess. Mrs. O'Briant seconded the motion. Roll Call Vote: Kirby aye, O'Briant aye. Motion passed 2-0.

At 5 pm, Mr. Kirby called the meeting back to order.

4. Certify the bond issue results for the September 8, 2015 Special Election for Sayre School District, for which Beckham County is the Control County. Mrs. O'Briant moved to certify the results. Mr. Kirby seconded the motion. Roll Call Vote: Kirby aye, O'Briant aye. Motion passed 2-0. (a copy of the Official Certification is attached and is a part of the permanent file.
5. Adjourn. Mrs. O'Briant moved to adjourn. Mr. Kirby seconded the motion. Roll Call Vote: Kirby aye, O'Briant aye. Motion passed 2-0.


