The Board reviewed two bids for the Fairground building remodel project, two dressing rooms. Motion made by Carl Don Campbell to accept BVG bid of \$16,100.00. Johnny Davis seconded the motion with Finnell, Davis & Campbell voting aye.

The Board reviewed two bids for the County Court Clerk remodel project, open wall between Clerk & old DA Office. Motion made by Carl Don Campbell to accept BVG bid of \$6,600.00. Johnny Davis seconded the motion with Finnell, Davis & Campbell voting aye.

Motion made by Carl Don Campbell to approve 2018 Dues, \$700.00 to Sweetwater Creek Firefighters Association on behalf of all Beckham County Fire Departments. Johnny Davis seconded the motion with Finnell, Davis & Campbell voting aye.

Judge Roper told the Board her office, corner of the second floor, is becoming a health hazard due to the bats. The smell & the mess they leave behind is not healthy for anyone to breath & especially those with breathing illnesses & compromised immune systems. She said the County Highway employees have power washed the outside window ledge before but that doesn't last very long. She suggested hiring a specialized cleaning company to come in & clean. Carl Don Campbell, said this needs to be cleaned and then do some prevention work to keep them out of the building. Motion made by Carl Don Campbell to investigate companies that do this type of work and get an estimate. Johnny Davis seconded the motion with Finnell, Davis & Campbell voting aye.

Judge Roper said Belinda Graham, Drug Court Coordinator, has had an office at the Sayre Broadway Center for over a year at no charge. The original plan was to move this office to the Courthouse, but this is not going to be feasible. The building is owned by the City of Sayre and they are willing to rent office space to Drug Court for \$300 per month. Belinda said this facility also meets their needs for space to conduct participant meetings. Judge Roper asked if the County would be willing & able to pay this rental fee, due to the Drug Court Program low State funding at this time. Motion made by Carl Don Campbell for the County to rent this building but to ask Roger Mills County & City of Elk City to pay a portion. Also, have the City of Sayre present this Board a rental agreement. Johnny Davis seconded the motion with Finnell, Davis & Campbell voting aye.

Rural Water District #2 was approved for REAP Grant \$40,881.00 to purchase E42 T4 Bobcat Compact Excavator. Motion made by Johnny to place order for Bobcat, title remains in Beckham County name for five years. Carl Don Campbell seconded the motion with Finnell, Davis & Campbell voting aye.
