SPECIAL EXECUTION AND ORDER OF SALE
WITH APPRAISEMENT

THE STATE OF OKLAHOMA, TO THE SHERIFF OF BECKHAM COUNTY, GREETINGS:

WHEREAS, on April 28th, 2023, in the above-entitled cause, the Plaintiff recovered a judgment against the Defendant(s), Dustin T. Hall and Veta K. 
with appraisalment, and, in accordance with said judgment and from the proceeds thereof, pay:
