SPECIAL EXECUTION AND ORDER OF SALE
WITH APPRAISEMENT

THE STATE OF OKLAHOMA, TO THE SHERIFF OF BECKHAM COUNTY, GREETINGS:

WHEREAS, on May 5, 2025, in the above-entitled cause, the Plaintiff recovered an In Rem judgment against the Defendant(s), Danny M.
