THE STATE OF OKLAHOMA TO THE SHERIFF OF BECKHAM COUNTY, OKLAHOMA, GREETINGS:

WHEREAS, on the <u>25</u> day of March, 2025, in Cause No. CJ-2024-91, wherein Bank of Western Oklahoma was plaintiff and Rickey Squires, a/k/a Rickey Gene Squires, and Deana Squires, husband and wife, and Seiling State Bank were defendants, the said plaintiff recovered a judgment against said defendants for the sum of \$822,673.49 principal, plus interest accrued and accruing thereon at the current per diem rate of \$185.58 from August 14, 2024, until paid; all late charges as provided by the note and mortgage, accrued and accruing from August 14, 2024, until paid; \$4,500.00 as a reasonable attorney's fee; and for the costs of the action and for accruing costs, as more fully set forth in the Judgment filed in said action, and a further decree of foreclosure of mortgage upon the following described real property situated in Beckham County, State of Oklahoma, to-wit:

Surface Only: Lot 7, and the West Half (W/2) of Lot 8, in Block 17, Houchens Addition to the City of Elk City, Beckham County, Oklahoma, according to the recorded plat thereof.

and directing the same to be sold, with appraisement, and to apply the proceeds arising

therefrom as follows:

FIRST:

In payment of the costs of the sale and of this action;

SECOND:

In payment of any back taxes owed on said property;

THIRD:

In payment to plaintiff the sum of \$822,673.49 principal, plus interest accrued

and accruing thereon at the current per diem rate of

\$185.58 from August 14, 2024, until paid; all late charges as provided by the

note and mortgage, accrued and accruing from August 14, 2024, until paid;

\$4,500.00 as a reasonable attorney's fee;

FOURTH:

That the residue, if any, be held to await further order of this Court.

NOW, THEREFORE, YOU ARE HEREBY COMMANDED that you proceed to levy upon and sell, with appraisement, according to law, and as directed by said Judgment, the land and tenements hereinbefore described and apply the proceeds arising from said sale as directed by said Judgment as aforesaid, and make due return of the Writ with your proceedings endorsed thereon, showing the manner in which you have executed the same.
