SPECIAL EXECUTION AND ORDER OF SALE
WITH APPRAISEMENT

THE STATE OF OKLAHOMA, TO THE SHERIFF OF BECKHAM COUNTY, GREETINGS:

Finally and the residue, if any, to be paid into Court to await the further order of the Court or a Judge thereof.

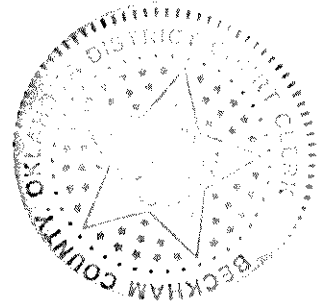
