## <u>FIRST ALIAS</u> <u>SPECIAL EXECUTION AND ORDER OF SALE</u>

THE STATE OF OKLAHOMA, TO THE SHERIFF OF BECKHAM COUNTY, GREETINGS:

WHEREAS, on November 29, 2022, in the above-entitled cause, the Plaintiff recovered a judgment against the Defendant(s), Linda L.
