## SPECIAL EXECUTION AND ORDER OF SALE

THE STATE OF OKLAHOMA TO THE SHERIFF OF BECKHAM, OKLAHOMA: GREETINGS:

WHEREAS, on September 27, 2022, in the above entitled and numbered cause, the Plaintiff recovered a judgment for the sum of \$93,119.24, with 4.375% interest thereon from November 1, 2021, until paid, and the further sum of a reasonable amount with interest per annum thereon, until paid; abstract expense of a reasonable amount with interest per annum thereon, until paid; and the further sum of \$6,500.00 attorney's fee, and for all the costs of this action, and recovered a further judgment decreeing the Plaintiff's mortgage set up and sued upon therein to be a valid, subsisting first and prior lien upon the real estate hereinafter described, for the full amount of the judgment, above set forth, and foreclosing said lien, and ordering that if said judgment be not paid, a second alias special execution may issue from the office of the Court Clerk, directed to the Sheriff of County, commanding said Sheriff to levy upon, and sell said real estate, with appraisement, after notice as provided by law, and
