WRIT OF GENERAL EXECUTION

STATE OF OKLAHOMA, to the Sheriff of Beckham County, in said state, Greetings:

WHEREAS, on June 15, 2020, Great Salt Plains Midstream, LLC obtained a judgment before the District Court of Oklahoma County, State of Oklahoma, against Big Chief Plant Services, LLC for the principal sum of \$307,488.09, together with pre-judgment interest of \$33,259.26, costs of \$560.20, and attorneys' fees of \$15,000, for a total of \$356,307.55, plus post-judgment interest at a rate of 6.75% (the "Judgment").

WHEREAS, on September 16, 2020, Great Salt Plains Midstream, LLC assigned all of its rights, title and interest in and to the Judgment was assigned to REP Processing, LLC.

WHEREAS, there has been no money paid and the total amount of the Judgment, with interest accrued and accruing, still due and owing to REP Processing, LLC is \$404,506.27 as of November 15, 2022, with interest accruing thereafter at the statutory rate from November 16, 2022, to the date of payment.

NOW, THEREFORE, YOU ARE HEARBY COMMANDED to satisfy the amount currently owed on the Judgment by taking into your possession and selling the nonexempt personal property of Big Chief Plant Services, LLC, 204 Ellis Lane, Elk City, Oklahoma, 73644, both


tangible and intangible, and including but not limited to all right, title, claim, and interest in the fraud claim of Big Chief Plant Services, LLC that is pending in the District Court of Weld County, State of Colorado, styled: *REP Processing, LLC v. Big Chief Plant Services, LLC, et al.*, Case No. 2019cv30940, and any verdict, report, decision, finding, rendition, order, judgment or decree in favor of Big Chief Plant, together with any and all products or proceeds (including cash proceeds) thereof, wherever found, and the right to compromise, settle, withdraw, or dismiss with prejudice such claim. If you are unable to find any personal property of Big Chief Plant Services, LLC, you are directed to endorse this Writ with "No Goods," and then satisfy the amount currently owed on the Judgment by execution and sale of all of the nonexempt real property of Big Chief Plant Services, LLC located in Beckham County, Oklahoma, up to the amount that is sufficient to satisfy the amount currently owed on the Judgment. If the personal property you are able to find is not sufficient to satisfy the amount currently owed on the Judgment, you are directed to satisfy the balance currently owed on the Judgment by execution and sale of all nonexempt real property of Big Chief Plant Services, LLC which is located in Beckham County, Oklahoma, up to the amount that is sufficient to satisfy the amount currently owed on the Judgment.

YOU ARE DIRECTED to endorse on this Writ the date and time you received it. You are also directed to return the Writ to the clerk of the court within 60 days of the date shown below with a report showing how you executed it.
